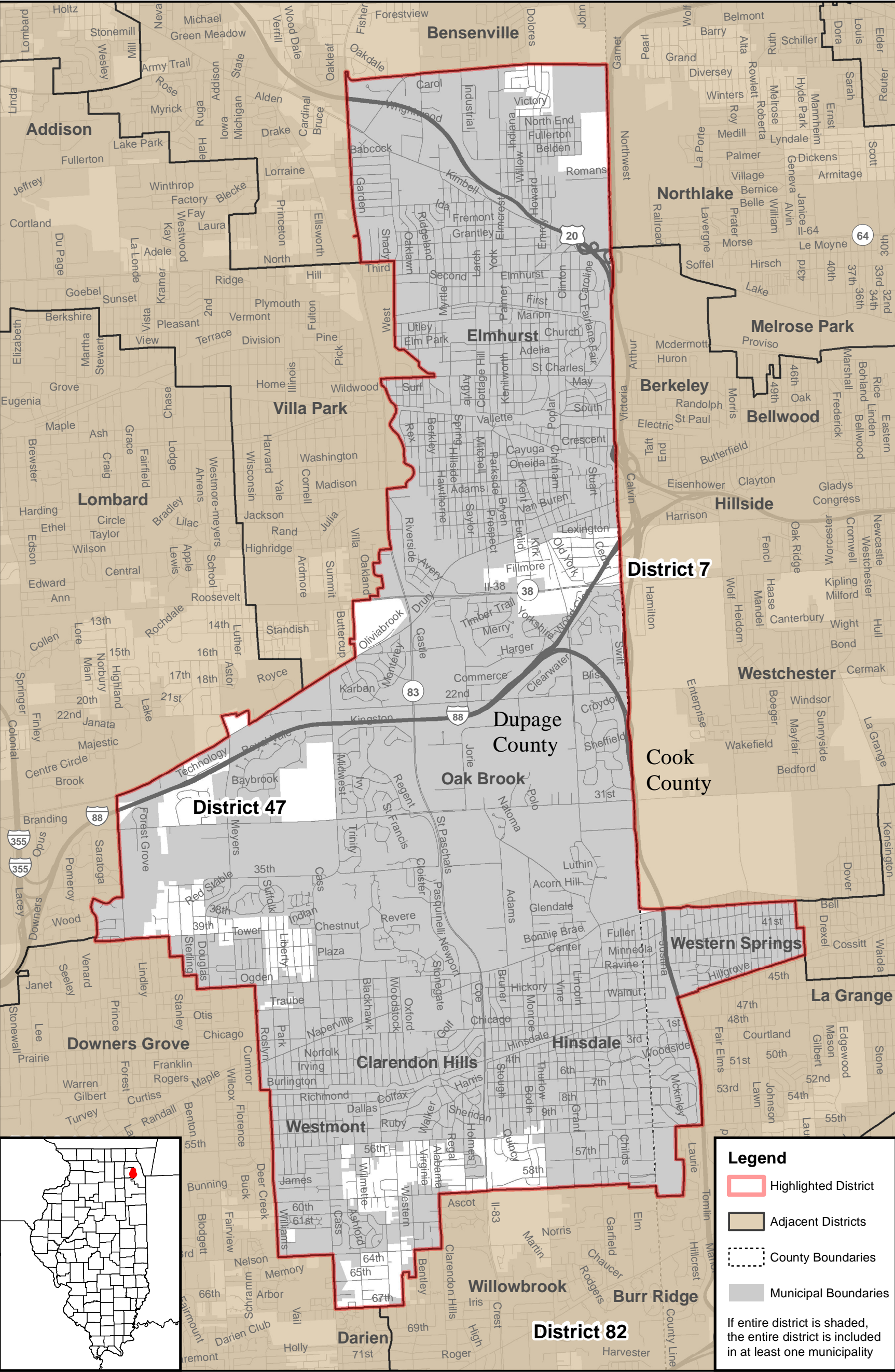


Illinois Representative District 47



Representative District 47

(Partially with Cook and DuPage Counties)

Representative District 47 shall include that part of Illinois beginning at a point ¼ mile north of I-290 on Il Route 83 in Addison (Dupage County),

thence east for approximately 120 feet to the east frontage road of Il Route 83,

thence south along the frontage road and continuing east along Old Grand Av to Old Grand Av (extended),

thence continuing east along Old Grand Av (extended), W. Grand Av and E. Grand Av to the Cook / Dupage County border,

thence south along the Cook / Dupage County border to E. North Av,

thence south along the Cook / Dupage County line to the northwest corner of Lyons Twp,

thence east along the Lyons / Proviso Twp border to Harvey Av,

thence south along Harvey Rd to 41st St,

thence east along 41st St to Gilbert Av,

thence south along Gilbert Av to Hillgrove Av,

thence southwest along Hillgrove Av to Hampton Av (extended),

thence south along Hampton Av (extended) to the Burlington Northern & Santa Fe rail line,

thence southwest along the Burlington Northern & Santa Fe rail line to the Tri-State tollway (I-294),

thence south along the Tri-State tollway (I-294) to E. 55th St,

thence west along E. 55th St for approximately 1300 feet,

thence south for approximately 1550 feet,

thence east for approximately 330 feet,

thence south for approximately 1700 feet along the Burr Ridge / Hinsdale border,

thence west along the Burr Ridge / Hinsdale border for approximately 1300 feet to S. County Line Rd (Dupage / Cook County line),

thence north for approximately 500 feet along the Cook / Dupage County border,

thence west along the Burr Ridge / Hinsdale border to S. Elm St,

thence north along S. Elm St for approximately 175 feet,

thence west to the intersection of 59th St and S. Garfield Av,

thence west along E. 59th St. and continuing west along E. 59th St (extended), to S. Madison St (the SE corner of the N ½ Section 14, T38N, R11E (3rd principal meridian),

thence continuing west along the south border of the SE corner of the N ½ Section 14, T38N, R11E (3rd principal meridian to 59th St,

thence continuing west along 59th St to Clarendon Hills Rd,

thence south along Clarendon Hills Rd to 63rd St,

thence west along 63rd St to Bentley Av,

thence south along Bentley Av to 65th St,

thence west along 65th St to its terminus between Bentley Av and Western Av,

thence north for approximately 300 feet,

thence west for approximately 300 feet,

thence south for approximately 150 feet,

thence west for approximately 70 feet to Western Av,

thence south along Western Av to 67th St,

thence west along 67th St to S. Cass Av,

thence north along S. Cass Av to E. 63rd St,

thence west along E. 63rd St to S. Williams St,
 thence north along S. Williams St to 59th St,
 thence continuing north along the west border of NE ¼ Section 16, T38N, R11E (3rd principal meridian) to W. 55th St,
 thence continuing north along S. Williams St to W. Burlington Av,
 thence west along W. Burlington Av to Roslyn Rd,
 thence north along Roslyn Rd to Ogden Av,
 thence west along Ogden Av to Douglas Rd,
 thence north along Douglas Rd to 41st St,
 thence west along 41st St to Sterling Rd,
 thence north along Sterling Rd to 40th St,
 thence west along 40th St to Glendenning Rd,
 thence north along Glendenning Rd to 39th St,
 thence west along 39th St to Highland Av,
 thence west along the south border of Section 32 T39N, R11E (3rd principal meridian) to Saratoga Av,
 thence north along Saratoga Av to Barneswood Dr,
 thence east along Barneswood Dr to Highland Av,
 thence north along Highland Av to Butterfield Rd,
 thence northeast along Butterfield Rd to Meyers Rd,
 thence north along Meyers Rd to approximately 90 feet south of 22nd St,
 thence east and south along the Oak Brook Terrace / Lombard municipal border for approximately 1300 feet,
 thence south to Butterfield Rd,
 thence northeast along Butterfield Rd to approximately 30 feet east of Myrtle Av,
 thence north for approximately 700 feet,
 thence west for approximately 200 feet to Myrtle Dr,
 thence north along Myrtle Dr for approximately 250 feet,
 thence east for approximately 250 feet,
 thence north for approximately 1800 feet to E. Roosevelt Rd,
 thence east along E. Roosevelt Rd to S. Monterey Av,
 thence north along S. Monterey Av to Frontage Rd,
 thence east along Frontage Rd to the terminus of Frontage Rd,
 thence north for approximately 350 feet,
 thence east for approximately 270 feet,
 thence north for approximately 600 feet,
 thence west for approximately 175 feet to the terminus of S. Wayside Dr,
 thence north along S. Wayside Dr for approximately 700 feet,
 thence east for approximately 300 feet,
 thence north for approximately 600 feet,
 thence east for approximately 500 feet to Kingery Hwy,
 thence north along Kingery Hwy to the south border of Section 10, T39N, R11E (3rd principal meridian),
 thence east along the south borders of Sections 10 & 11, T39N, R11E (3rd principal meridian) to Salt Creek,
 thence north along Salt Creek to W. St. Charles Rd,
 thence east along W. St. Charles Rd to S. Berkley Av,
 thence west and northwest along S. Berkley Av to Alma Av,
 thence northwest along Alma Av to W. Elm Park Av,
 thence west along W. Elm Park Av to S. West Av,

thence north along S. West Av to W. North Av,
thence west along W. North Av to Kingery Hwy,
thence north along Kingery Hwy to the point of beginning.
