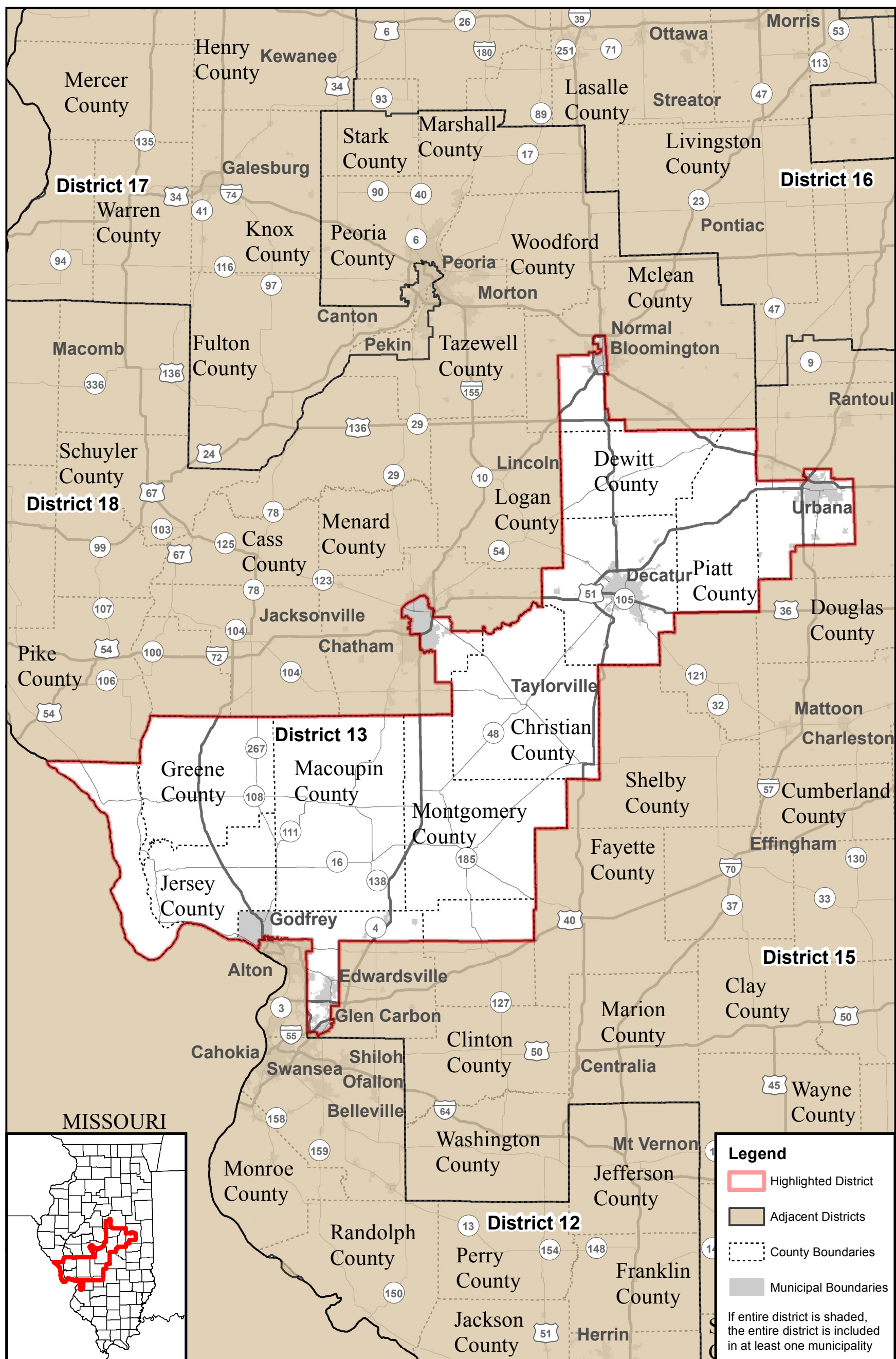


Illinois Congressional District 13

Encompasses parts of McLean, Champaign, Sangamon, Bond and Madison Counties, and entirely encompasses Dewitt, Piatt, Macon, Christian, Montgomery, Macoupin, Greene, Calhoun, and Jersey Counties,

US Congress District 13 begins at the northwest corner of Dale Twp in McLean County,

 thence west along the Philo / Crittenden Twp border and continuing west along the Pesotum / Tolono Twp border to County Road 700 E,
 thence south along County Road 700 E to County Road 500 N,
 thence west along County Road 500 N and continuing west along County Road 500 N (extended) to the Sadorus Twp border,
 thence south along the Sadorus / Pesotum Twp border to the Douglas County border,
 thence west along the Douglas / Champaign County border to the Piatt County border,
 thence south and west along the Piatt / Douglas County border to the Moultrie County border,
 thence west along the Moultrie / Piatt County border to the Macon County border,
 thence west, south, west and south along the Macon / Moultrie County border to the Shelby County border,
 thence west along the Macon / Shelby County border to the Christian County border,
 thence south and west along the Christian / Shelby County border to the Montgomery County border,

 thence south along the Ft. Russell / Hamel Twp border, and continuing south along the Edwardsville / Pin Oak Twp border to the southeast corner of Edwardsville Twp,
 thence west along the Edwardsville / Collinsville Twp border to S. IL Rt 159,
 thence south along S. IL Rt 159 to I-70,
 thence east along I-70 to the east border of Section 14, T3N, R8W (3rd principal meridian),

thence west along Cleveland St to Collinsville Av,
thence south along Collinsville Av to St. Louis Rd,
thence southwest along St. Louis Rd to Sycamore St,
thence north along Sycamore St for approximately 1570 feet,
thence west for approximately 610 feet to the west border of Section 33, T3N, R8W (3rd principal meridian),

thence south along 31st St to E. Elm St,
thence east along E. Elm St for approximately 1100 feet,

thence east for approximately 1510 feet to the west border of Section 30, T16N, R4W (3rd principal meridian),
thence south along the west border of Section 30, T16N, R4W (3rd principal meridian) for approximately 2630 feet,

thence continuing north along the Funk's Grove / Mount Hope Twp border, and continuing north along
the Allin / Dale Twp border to the point of beginning.
